

GENERAL TERMS AND CONDITIONS OF SALE PLEASE READ CAREFULLY

All sales by Ozone Water Systems, Inc. are subject to and made upon the following terms and conditions.

A. SALES POLICY

1. OZONE WATER SYSTEMS, INC. STANDARD TERMS AND CONDITIONS

Ozone Water Systems, Inc. ("OWS") sells products for business use to customers with proper business identification, which is required from all customers prior to purchase.

2. Prices.

Prices do not include freight, handling fees, taxes, and/or duties, and are subject to correction or change without notice. Market sensitive commodity products will be priced according to current market conditions. Customer should contact the local Ozone Water Systems, Inc. branch or check online at www.ozonewatersystems.com for current pricing. Export orders may be subject to other special pricing. Ozone Water Systems, Inc. reserves the right to accept or reject any order.

3. Sales Tax.

Customers are responsible for payment of all applicable state and local taxes, or for providing a valid sales tax exemption certificate. When placing an order, customer shall indicate which products are tax exempt.

4. Payment and Credit Terms.

Ozone Water Systems, Inc. accepts checks, Visa, MasterCard, and American Express.

For customers with established Ozone Water Systems, Inc. credit, payment terms are net thirty (30) days from the date of shipment or pick-up, unless other arrangements have been agreed to by both parties. All credit extended by Ozone Water Systems, Inc. to customer, and the limits of such credit, is at Ozone Water Systems, Inc.'s sole discretion, and may be reduced or revoked by Ozone Water Systems, Inc. at any time, for any reason. Ozone Water Systems, Inc. reserves the right to charge customer a late payment fee at the rate of one and one-half percent (1-1/2%) of the amount due for each month or portion thereof that the amount due remains unpaid, or such amount as may be permitted under applicable law. Anticipation and cash discounts are not allowed without prior agreement by both parties. Export orders are subject to special export payment terms and conditions. All payments must be made in U.S. dollars. Ozone Water Systems, Inc. shall have the right of set-off and deduction for any sums owed by customer to Ozone Water Systems, Inc. If customer fails to make payment within thirty (30) days of shipment or pick-up, or fails to comply with Ozone Water Systems, Inc.'s credit terms, or fails to supply adequate assurance of full performance to Ozone Water Systems, Inc. within a reasonable time after requested by Ozone Water Systems, Inc. (such time as specified in Ozone Water Systems, Inc.'s request), Ozone Water Systems, Inc. may defer shipments until such payment or compliance is made, require cash in advance for any further shipments, demand immediate payment of all amounts then owed, elect to pursue collection action (including without limitation, attorneys' fees and any and all other associated costs of collection), and/or may, at its option, cancel all or any part of an unshipped order. Customer agrees to assume responsibility for, and customer hereby unconditionally guarantees payment of, as provided herein, all purchases made by customer, its subsidiaries and affiliates. Each of customer's subsidiaries and affiliates purchasing from Ozone Water Systems, Inc. will be jointly and severally liable for purchases with customer, and customer is also acting as agent for such subsidiaries and affiliates.

5. Credit Balance.

Customer agrees that any credit balance(s) issued by Ozone Water Systems, Inc. will be applied to customer's account within one (1) year of its issuance. **IF CUSTOMER HAS NOT REQUESTED THE CREDIT BALANCE WITHIN ONE (1) YEAR, ANY REMAINING CREDIT BALANCE WILL BE CANCELLED, AND OZONE WATER SYSTEMS, INC. SHALL HAVE NO FURTHER LIABILITY.**

B. FREIGHT POLICY

Prices stated are F.O.B. origin, freight prepaid to destination specified in the order. Insurance is added to all prepaid and add shipments. Ozone Water Systems, Inc. charges a shipping and handling fee (which includes internal handling and related costs) on each order which is applied at time of order and reflected on customer's invoice. Receipts for shipping and handling charges will not be furnished. Any order requiring crating will be charged accordingly unless the quote specifically indicates shipping and crating included in the sale price. C.O.D. shipments are not permitted. Other terms and conditions may apply for other than

standard delivery ("Other Freight Services"), including without limitation, expedited same day delivery, air freight, freight collect, export orders, hazardous materials, customer's carrier, shipments outside the contiguous U.S., or other special handling by the carrier. Any charges incurred for Other Freight Services must be paid by customer. Fuel surcharges may be applied. Title and risk of loss pass to customer upon tender of shipment to the carrier. If the product is damaged in transit, customer's only recourse is to file a claim with the carrier.

1. LIMITED WARRANTY.

ALL PRODUCTS SOLD ARE WARRANTED BY OZONE WATER SYSTEMS, INC. ONLY TO CUSTOMERS FOR: (i) RESALE; OR (ii) USE IN BUSINESS, GOVERNMENT OR ORIGINAL EQUIPMENT MANUFACTURE. OZONE WATER SYSTEMS, INC. WARRANTS NEW PRODUCTS AGAINST DEFECTS IN MATERIALS AND WORKMANSHIP UNDER NORMAL USE FOR A PERIOD OF ONE (1) YEAR AFTER THE DATE OF PURCHASE FROM OZONE WATER SYSTEMS, INC., WARRANTS REFURBISHED PRODUCTS FOR A PERIOD OF 6 MONTHS, AND ALL USED PRODUCTS ARE WARRANTED FOR A PERIOD OF 60 DAYS, UNLESS OTHERWISE STATED. PROVIDED THAT OZONE WATER SYSTEMS, INC. ACCEPTS THE PRODUCT FOR RETURN DURING THE LIMITED WARRANTY PERIOD, OZONE WATER SYSTEMS, INC. MAY, AT ITS OPTION: (i) REPAIR; (ii) REPLACE; OR (iii) REFUND THE AMOUNT PAID BY CUSTOMER. CUSTOMER MUST RETURN THE PRODUCT TO THE APPROPRIATE OZONE WATER SYSTEMS, INC. BRANCH OR AUTHORIZED SERVICE LOCATION, AS DESIGNATED BY OZONE WATER SYSTEMS, INC. SHIPPING COSTS PREPAID. OZONE WATER SYSTEMS, INC.'S REPAIR, REPLACEMENT, OR REFUND OF AMOUNTS PAID BY CUSTOMER FOR THE PRODUCT, SHALL BE CUSTOMER'S SOLE AND EXCLUSIVE REMEDY.
